Travel and Accommodation Allowance Guidelines

Effective Date: 3 August 2022

The Travel and Accommodation Allowance (**TAA**) is a contribution by the Department for Education (DfE) to the costs incurred by employers when apprentices and trainees are required to travel long distances to a Nominated Training Organisation (**NTO**) that delivers their qualification. An NTO may be either a Registered Training Organisation or a recognised higher education provider.

This allowance is a **contribution only** and is not intended to cover the total travel and accommodation costs. Any additional travel and accommodation costs incurred as a result of an apprentice or trainee attending off the job training may be the responsibility of the employer (see **Provisions under modern awards** below).

Eligibility criteria

To be eligible to receive an allowance, an employer must employ an apprentice or trainee that:

- has an approved Training Contract registered in South Australia, under the South Australian Skills Act 2008 (SA);
- is required to travel in excess of 150 km (round trip) between his/her normal place of residence and the nearest training venue offering the apprenticeship/traineeship qualification; and
- resides within a non-metropolitan area of South Australia, unless the travel allowance relates to interstate travel pre-approved by DfE. The list of pre-approved qualifications is provided at Schedule A – Travel and Accommodation Allowance Interstate Delivery List.

Guidelines

- Employers must lodge an application online via https://www.skills.sa.gov.au/business/support-for-business/travel-and-accommodation-allowance after the apprentice/trainee has attended the training block for which the allowance is being claimed, and within six months from the last day of the training block being claimed. The call up notice issued by the NTO must be attached to the application. DfE can only accept applications that have been submitted using the online form.
- **Travel allowances** are a pre-determined rate based on the distance travelled from the place of residence (Residential Address) of the apprentice or trainee to the closest contracted NTO able to deliver the off-job training:
 - o Intrastate 30c per kilometre for the shortest practical route
 - o Interstate calculated on a set rate based on an economy airfare

Note: Residential Address is where the apprentice or trainee normally resides. Residential Address is not the address where the apprentice or trainee lives while away working (e.g. if an apprentice resides in Norwood, Adelaide and lives in Olympic Dam while working (works for two weeks at Olympic Dam and one week off home at Norwood, Adelaide), then Norwood, Adelaide is the Residential Address).



Guidelines (cont'd)

- Accommodation allowances (weekends and public holidays that occur within a training block will be included for calculating entitlement)
 - o Intrastate \$60 per day
 - o Interstate \$110 per day for pre-approved training delivered in other states
- No receipts are required for travel and accommodation costs incurred.
- The maximum allowance payable for each apprentice or trainee per calendar year is limited to eight return trips and accommodation for 48 days.
- If the employer together with the apprentice or trainee selects an NTO that is not the closest contracted NTO offering the qualification, an allowance will only be paid for the distance that would be travelled to attend the closest contracted NTO.
- Allowances to attend off the job training interstate will only be paid where there is no NTO scoped and able to the deliver the qualification in South Australia. Qualifications approved for travel interstate can be viewed in Schedule A Travel and Accommodation Allowance Interstate Delivery List.
- Employers will only be eligible for an allowance where the apprentice or trainee has attended the training block being claimed. If an upcoming training block is cancelled or postponed after accommodation has been booked and a deposit paid, the employer and/or the apprentice/trainee should pursue a refund with the accommodation provider. The TAA cannot pay for a deposit that is lost through cancellation. As a due diligence measure, it is suggested that the accommodation provider's refund policy be carefully checked prior to booking.
- All allowances must be paid into a bank account held in the employer's legal or trading name. Payments cannot be made directly to an apprentice or trainee.
- Payments for eligible training blocks will be transferred to the employer's nominated bank account within 10 business days of application receipt.

Goods and Services Tax (GST)

On advice from the Australian Taxation Office (ATO), GST does not apply to this allowance.

All claimed amounts must be exclusive of GST. The only exception to this is if the organisation that paid these expenses is not registered for GST.

Provisions under modern awards

Many modern awards require employers to reimburse apprentices for the full cost of them being required to travel to and attend off-the job training, so long as the apprentice makes satisfactory progress. Employers should refer to the award or other industrial agreement on the Training Contract.

The amount payable by an employer can be offset by the amount received through the DfE travel and accommodation allowances.

If the award or other industrial agreement in operation is silent on the provision of travel and accommodation arrangements, responsible employers will ensure that their apprentice or trainee is fully supported and is not out of pocket as a result of having to travel to attend off the job training.

Calculation of Travel and Accommodation Allowance payment rates

The Travel and Accommodation Allowance amounts payable are calculated based on the distance from the apprentice's residential address to the training venue of the closest contracted NTO able to deliver the off the job training.

Residential Address	Training venue of closest contracted NTO	Travel allowance	Accommodation allowance
Metropolitan	Metropolitan	Nil	Nil
Metropolitan/Regional	Interstate - round trip Distance greater than 1000 km (refer Schedule A – Travel and Accommodation Allowance List)	Adelaide-Melbourne \$350. Adelaide-Sydney \$400. Adelaide-Queensland \$550.	\$110/night.
Regional	Metropolitan/regional - round trip Distance 150km or less	Nil	Nil
Regional	Metropolitan/regional - round trip Distance greater than 150km	Allowance as determined by Department	\$60/night

Examples of Travel and Accommodation Allowance payment rates

1. Apprentice A – Interstate travel

Apprentice A is a locksmith apprentice whose normal place of residence is Prospect, which is in the Adelaide metropolitan area. The closest contracted NTO who delivers the required training is in Melbourne and the Department has pre-approved this travel.

After Apprentice A attends each 2-week training block, the employer may claim the following:

Total	\$1,670.00
Travel allowance (Adelaide to Melbourne) – set rate based on economy airfare	\$350.00
Accommodation – 12 nights @ \$110/night	\$1,320.00

2. Apprentice B – Nearest contracted NTO

Apprentice B's normal place of residence is Port Lincoln and has selected an NTO in Adelaide. However, the closest contracted NTO who delivers the training is at Port Augusta. Accordingly, Apprentice B is entitled to allowances based on travel from Port Lincoln to Port Augusta. For a 2-week training block, then, the employer of Apprentice B may claim the following:

Port Lincoln to Port Augusta

Accommodation – 12 nights @ \$60.00/night	\$720.00
Travel allowance (341km x .30 Cents) X 2 = \$205	\$205.00
Total	\$925.00

However, had the closest contracted NTO been in Adelaide, the employer of Apprentice B would have been able to claim:

Port Lincoln to Adelaide

Accommodation – 12 nights @ \$60.00/night	\$720.00
Travel allowance (650km x .30 Cents) X 2 = \$390.00	\$390.00
Total	\$1,110.00
